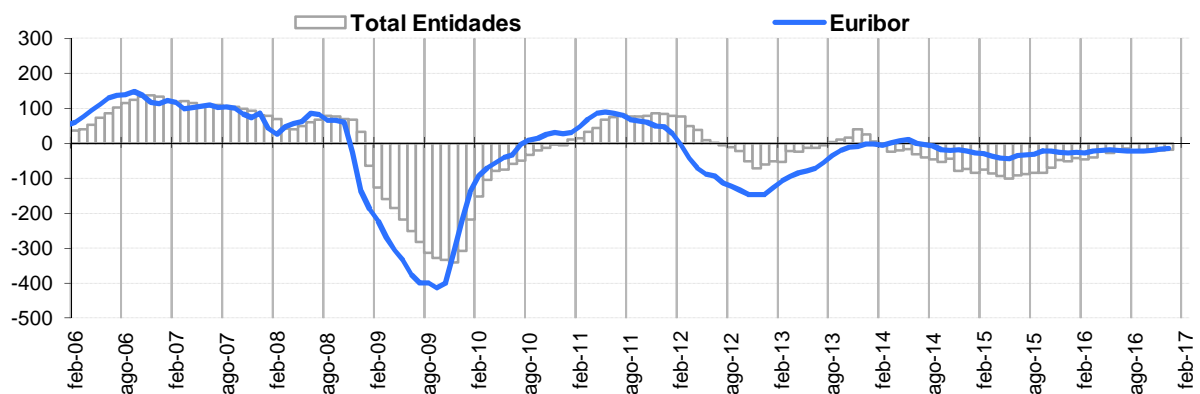

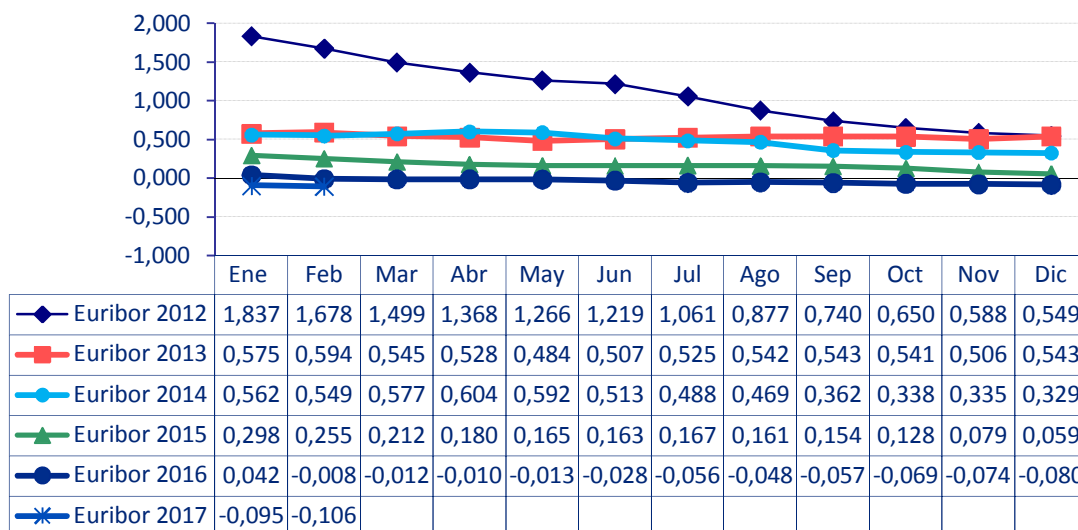

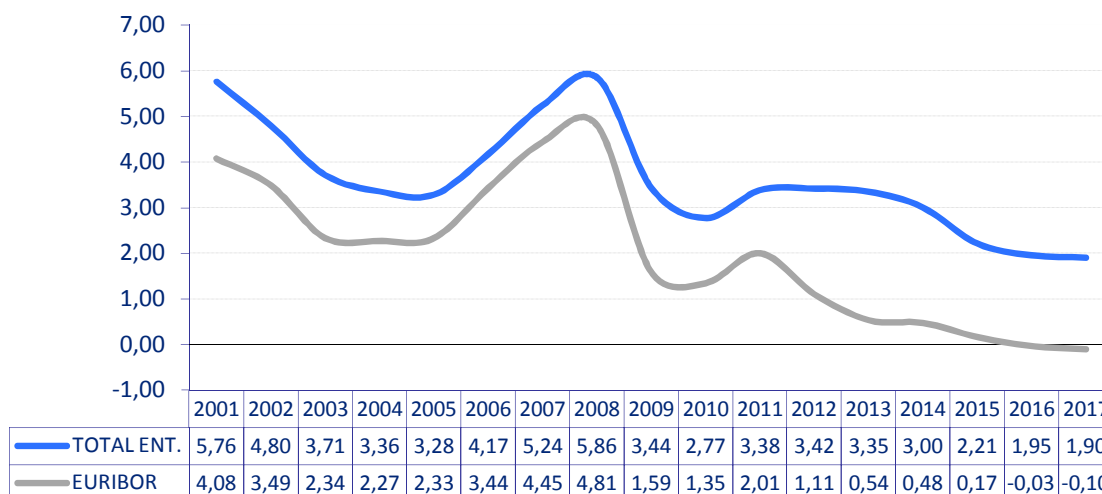

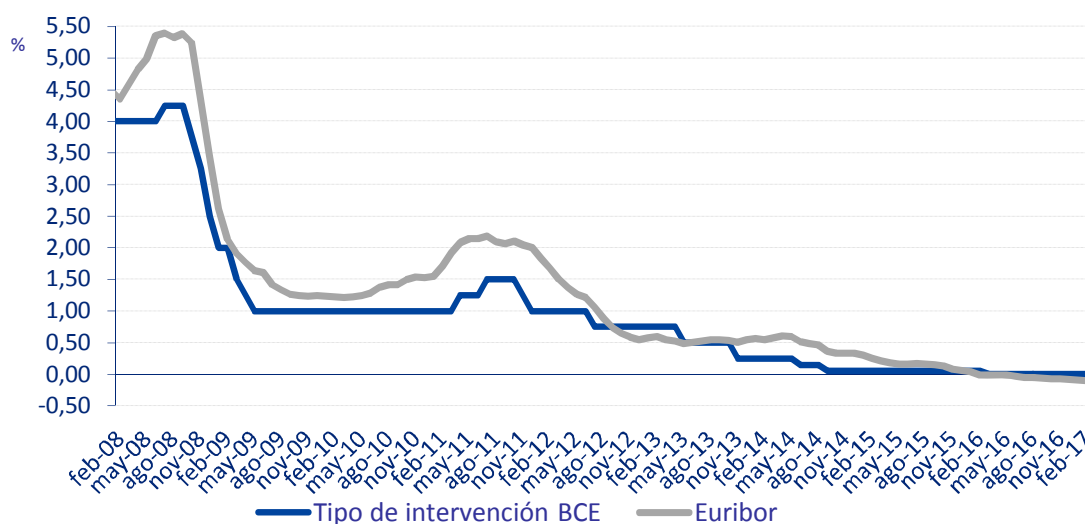

Euribor 12 monthly average
